Personal Information explained

Personal information is information about an identified individual, or an individual who is reasonably identifiable.

Bathurst Family History Group Inc. retains personal information supplied by the member for the purpose of identifying current membership and for contact purposes with its members.

Privacy Statement

How is This Data Used?

From time to time we contact members to advise of meetings, events, changes to our policies etc. Generally, this is done via the supplied email address or through our quarterly newsletter.

Storage of Personal Information

BFHG retains your supplied person information in a secure database accessible only by the Public Officer/Secretary and Member Secretary. The Treasurer has limited access to the database and accesses supplied bank/credit card details (which are not retained) for payments relating to membership and purchases.

Disclosure of Personal Information

Personal information you provide to us will not be disclosed to other organisations or individuals without your express permission.

Security of Personal Information

BFHG keeps membership and mailing list subscriber details and web server logs on controlled facilities (such as Dropbox, MailChimp email service) that are secured against unauthorised access. The owner of the information must give permission to allow it to be released. Proof of identity is required before information is released to any person.
